# 1. What is Forensic Genealogy?

Defined as genealogical research involving, analysis and reporting in cases with legal implications." [Copyright Dee Dee King - 2008.]. Most of the cases involve living people, which distinguishes forensic genealogy from traditional family research. The standards remain the same, but we use more recent census and obituary records for instance and seldom delve into records such as tax, Pre Civil War Census, Church, and other traditional sources. The field is dynamic, growing, challenging, and takes a great deal of genealogical experience to practice and master.

#### 2. Missing and Unknown Heir cases

Forensic genealogists are employed in a wide variety of cases involving missing and unknown heir cases involving testate and intestate estates. State law governs important matters such jurisdiction of probate proceedings, who can search for heirs, who is an heir, and if records needed to find heirs are open or closed to the forensic genealogist for research. The heir search industry has important ethical and legal considerations such as Champerty to consider when conducting their business. The booming Oil and Gas Industry and leasing of Mineral Rights have a great need for skilled Forensic Genealogists.

#### 3. Adoption Research

Adoption Research is among the most challenging research projects any genealogist will encounter. Our country has had a history of open access to adoption records, to closed records, with a trend in recent years towards open records. Six in ten Americans has a close family

member or close friend in the adoption Triad (Adoptee, Birthparent, or Adoptive Parent). Forensic Genealogists need to be creative, persistent, and ethical when searching for a birthparent or searching for an adoptee put up for adoption for a client.

# 4. Citizenship and Immigration Cases

Dual Citizenship offers many advantages to those who are eligible such as ease of travel, a sense of ethnic pride, a gift to your children, access to cutting edge medical treatments, among other reasons. The most common countries to seek citizenship are Ireland and Italy but other countries offer the benefit.

### 5. Military Repatriation

Military repatriation is defined as the return of remains of servicemen to their country of origin. Forensic Genealogists who practice in this field find this work among the most rewarding of their career. The genealogist's work consist of finding next of kin of a serviceman killed in action for matching DNA to remains that may be found from a recovery mission conducted by JPAC (Joint POW/MIA Accounting Command). Those remains are then returned to the family for burial.
